# The System of Disaster Management Administration, Possibilities for Improvement

#### **1.THE SUBJECT OF RESEARCH**

Disaster management administration changed fundamentally on 1 January 2012. As a result, the management, organisation and legislative environment of fire protection, disaster management and civil protection became uniform. Before 1 January 2012 the organisation of disaster management had not been uniform, and there had been overlaps in the tasks of state organisations, administration bodies and mayors in charge of disaster management, which led to confusions in the management of prevention and response. Taking it into account, a new system of management and responsibilities was created. The legal framework was modified and the system of management and responsibilities became clear. Modifications in the disaster management related tasks of international organisations – UN, European Union, NATO – have also contributed to this change. The dissertation elaborates on the effects of the changes, the revision and the analysis of the realisation of the uniform system as well as makes recommendation on development.

#### 2. Research objectives

- The primary goal of research is to elaborate on the possibilities of development based on the evaluation of the changes in disaster management administration:
- I **summarise** the system of disaster management, the function of defence administration, the circumstances of the evolvement of its fields in various legal and international contexts.
- I analyse and evaluate the tasks of disaster management administration and their components.
- I describe the international elements of the changes in disaster management and assess the resulting changes in Hungary.
- I examine the legal, economic and international changes and their relationship.
- I make recommendations on the modification of certain components of disaster management administration.

### **3.RESEARCH METHODS**

General research methods were applied: analysis, deduction and synthesis.

- National legislation on disaster management was studied and examined, reports were assessed and the relationship between legislations was outlined.
- I carried out research on legal history.
- I examined the relevant research findings in this field.
- I compared national and international legislation and various agreements and their influence on disaster management in Hungary.
- I studied and evaluated the changes, trends occurring in international disaster management and their impact on disaster management in Hungary.
- I examined the tasks of disaster management and the assessment of administration processes based on field consultations.
- I participated in professional conferences, whose findings were collected and evaluated.
- I studied relevant dissertations, national and international specialist literature in the field of disaster management.

### 4. THE OUTLINE OF THE THESIS

# I. THE CONCEPTUAL SYSTEM OF DISASTER MANAGEMENT

The main content points of the definition are identical. In order to form a universal definition that is applicable to every country, we need to identify the main points they share. They are the following:

- Human life and property are adversely affected (they are severely damaged). The population and their basic supply are in danger, it cannot be guaranteed or only to a minimal extent (it endangers subsistence). Abnormal situations develop at all levels of society and state administration, and it has a prolonged effect.
- Preventing or mitigating the consequences exceeds the capabilities of related organisations, communities and the state. Well-organised, coordinated response is needed, which might necessitate international assistance.

#### **II. FACTORS INFLUENCING PROTECTION AGAINST DISASTERS UNTIL 31 DECEMBER 1999**

As regards the tasks, the following characterised this period:

Different pieces of legislation contained the tasks of protection against disasters, which was sporadically defined and closely linked to defence management until 1989. Then, Protocol I Additional to the Geneva Conventions provided a common framework for international tasks related to protection against disasters, which our system had to be aligned with. Following this period, protection related tasks began to be harmonised, which was supported by our efforts to join the European Community in 1991 and certain stages of the accession negotiations. Hungary entered into several international agreements on industrial activities, hazardous materials and waste in the early and mid-1990s. As a result, safety gained greater emphasis in industrial activities. The Association Agreement with the European Community on 16 December 1991 was another milestone in the field of preventing industrial accidents involving hazardous materials. Civil protection, fire service and local governments performed the tasks assigned by the government but none of them were appointed to take over control. Activities related to prevention used to be fragmented as well. Management of prevention was divided between defence and committee bodies.

There did not used to be a uniform government regulation or a single organisation to coordinate response to disasters. The state gradually withdrew from fire protection and local governments took over its role. There were changes in the management of civil protection tasks, too. Ministries of Defence and Interior supervised these activities alternately. Institutional system in charge of authority tasks related to disaster prevention was not unified.

### III. REVIEW OF DISASTER MANAGEMENT BETWEEN 1 JANUARY 2000 AND 31 DECEMBER 2011

The legislation that came into effect on 1 January 2000 altered the institutional system and the coordination of disaster management. The highest level of coordination was moved from the Parliament to the government, which increased effectiveness and the possibility of operational intervention. Protection against disasters was still in the hands of civil protection, involving fire departments as first response units and accompanied by citizen involvement based on their civil protection duties. A deficiency of the legislation was that the state was not authorized to enforce the rules. The content of laws in effect related to disaster management was contradictory, so they needed revising. The system to prevent accidents involving hazardous materials was established. Since joining the European Union on 1 May 2004, the related community law regulated the tasks and activities involving hazardous materials. The lack of a wide range of sanction instruments - a type of means of prevention - to enforce rules on dangerous establishments was a deficiency. As regards fire protection, local governments still played a major role. They education and training

system of this field needed a reorganisation. The high number of participants in various trainings, the wide selection of training forms and the great demand for technical equipment in trainings made it necessary to involve all organisations affected, including MoI National Directorate General for Disaster Management, the county directorates for disaster management and the Disaster Management Training Centre.

## **IV. CHANGES IN DISASTER MANAGEMENT SINCE 1 JANUARY 2012**

In this chapter I revised the main changes in disaster management since 2011. Changes in the legislation offered a framework that made administration more effective in this field. In order to increase effectiveness the organisation had to be changed. Instead of the former system of deputy director generals, the system of inspectorate generals was founded, which meant the separation of the different fields. Protection against disasters was renewed in the European Union, which led to modifications in the Hungarian system as well. A major progress within protection against disasters has been made in public information. In Hungary the internet and telecommunications technology have been gaining ground in this field, which serves the safety of the population. As regards dangerous materials, compliance with the regulations was achieved in establishments within the scope of the law through changes in the legislation. Following the reorganisation of fire protection within disaster management and placing it under the control of the state, the establishment of disaster management stations increased the safety of the citizens. Authority tasks give more support to prevention. An activity that has been recently included in the jurisdiction of disaster management is the supervisory task. The foundations of the system of critical infrastructure protection have been laid down in Hungary, currently fine-tuning is in progress within the sectors. The safety of the settlements has also been increased by the measure of the Disaster Management Act that provides for the mandatory public safety assistant, besides the mayor, in settlements that are assigned to class I or II.

#### **5.SUMMARISED CONCLUSIONS**

In my dissertation I described the main stages of the development of disaster management in Hungary, and the changes in the significant components. Protection against disasters is not a static but a dynamic process, which is in constant change. I have proved that several external and internal factors have to be considered.

The critical examination of the various stages of protection against disasters led to conclusions, based on which I make recommendations that contribute to the development of this field.

## 6.New scientific achievements

- 1) I was the first to prove, based on my wide range of law history researches in the field of tools, determining the organization and function, legislation, legal regulating the professional disaster management authority, as well as its predecessors, that the need for a professional framework of "protection against disasters" in Hungary had been formulated clearly earlier than the change of the political system, first by defense legislation.
- 2) I have ascertained, following a comprehensive, critical examination and extensive analysis of the changed legal and institutional framework of the renewed disaster management system, that the transformation of the professional disaster management into a unified organization, on 01 January 2012, increased the effectiveness of the protection against disasters, the established organizational and authoritative system is functioning more uniformly. I have proven it by the decreasing number of firefighting turnouts. I have confirmed that the single integrated disaster management provides a greater safety for the population as regards the guarantee of fundamental rights to be provided by the state.

- 3) I have proved that the international processes and documents of the United Nations and the European Union have had a great impact on the development of disaster management in Hungary in the strengthening of voluntarism, however, the organizational and management system of the protection against disasters were developed in accordance with national particularities.
- 4) I was the first to indicate and prove by examples that voluntary activities increasingly occur in the course of protection against disasters, but the guarantee of the proper implementation of search and rescue operations is primarily provided by a technically well-equipped, trained and classified rescue organization, based on INSARAG guidelines, on a voluntary basis, from the professional staff of disaster management.
- 5) Examining the roles of disaster management, I have made specific proposals to further improve the efficiency of protection on a municipal level, in case of non-fulfillment of disaster management tasks by the mayor, to sanction it; and optimize the activities of the public safety officer, as well as on the training program of operators and authoritative officials, the implementation of a higher-level professional functioning of disaster management organs.

### **7.PRACTICAL APPLICATION OF RESEARCH FINDINGS**

My dissertation offers a comprehensive description of a major period in the development of disaster management in Hungary and its stages. The findings of my research can primarily be used in education. Moreover, the results can be used to improve the administration tasks of disaster management as well as to increase the effectiveness of management.

#### 8. RECOMMENDATIONS

- In my thesis, I am comprehensively presenting the main periods of the development of protection against disasters and disaster management administration, breaking it down to historical and administrative sections, expediently chosen by me. I am proposing to use the results of my research primarily in disaster management training, during higher education and post-secondary education, as follows:
- 1. During the teaching of disaster management bachelor's degree program, within the framework of administration subjects.
- 2. It may serve as a basis for further better organization of evaluation of authoritative and protection tasks.
- 3. The thesis is to be used for the professional training of mayors and public safety officers.
- 4. The thesis may be used partly in the teaching of higher vocational education, and within, for general administration tasks.
- 5. The thesis may be used for teaching disaster management BA and MA undergraduates of NUPS, on the occasion of teaching law and profession history.

Ascertainments formulated in the thesis:

- may be used in the formulation of the development concepts of disaster management and long-term development programs,
- may provide basis to determine the rates of development of the organization and scope of tasks,
- may be suitable as educational aids for the training methods, as suggested above, may form the basis of amending the legal instruments governing the organization. My thesis may provide a basis for future research to be carried out in this special field. My recommendations may help the work of decision-makers and may also promote the upgrade of the disaster management and firefighting equipment pool.
